to undertake to write the doctoral thesis according to what is indicated in the Regulations of the Research Doctorate Courses of the University for Foreigners of Siena;

to formally undertake to carry out the envisaged research periods abroad during the three-year period of the course (minimum 6 months);

to be aware that failure to stay abroad will result in the revocation of the entire scholarship;

to formally undertake to carry out the envisaged research periods at companies and research centers and abroad, if foreseen;

to be aware that the modification of the project objectives and expected results (if it has not been previously authorized by the MUR) will result in the revocation of the scholarship and the total refund of any amounts already paid;

to be available to attend courses for the acquisition of soft skills and knowledge on the world of work and research, which will be proposed by the implementing body during the three-year PhD period;

to undertake to draw up annual reports for each year of the doctorate and a final report on the training activities attended and on the research activities undertaken and on the degree of satisfaction;

to produce a report indicating the time commitment (divided into months in the company, at headquarters, abroad, if required) and a summary of the main activities carried out according to the indications of the MUR;

to formally undertake to respect the deadlines established by the MUR, to provide all the documentation and information requested by the University or by the MUR, and to guarantee timely direct information to the University of any substantial change involving changes to the original objectives and expected results selected projects, or on the initiation and progress of any judicial, civil, criminal or administrative proceedings that may affect the operations covered by the project, also communicate the irregularities, frauds, cases of corruption and conflicts of interest encountered;

to be aware that any negative judgment from the Academic Board and the consequent non-admission to the following year of the doctoral course will result in the revocation of the sums
