**TO THIS END, I DECLARE THAT**

pursuant to art. 46 of the Presidential Decree 445 of 12/28/2000, to be aware of the penal sanctions in the case of untruthful declarations, the formation or use of false documents, referred to in art. 76 of the same Presidential Decree, the following:

- a) I am less than 35 years old at the time of application for admission to the doctoral programme selection procedure;
- b) I have B2-level proficiency in spoken and written English
- c) I am willing to carry out periods of study and research abroad for at least six months over the course of three years , I am aware that failure to complete research and periods of study abroad may result in the Regione Toscana revoking the entire scholarship
- d) their willingness to carry out at least 3 months of training/research experience in an applied context, such as a company, a public research body, another public institution (not a university) and to be aware of the revocation of funding for the entire grant from the Region;
- e) I am able to attend courses to acquire soft skills and knowledge of the job world and the field of research, that will be proposed by the project supervisor over the course of the three-year doctoral programme;
- f) to be aware that the Tuscany Region does not reimburse the costs of scholarships for PhD students who withdraw during the first three months of the course and that therefore, in the event of renunciation, in any case justified, or interruption of the course in the first three months, without having achieved any documented result in terms of skills acquired, the University for Foreigners of Siena is required to request the return of the months received.
- g) to be aware that in the event of withdrawal or interruption of the course in the first 3 months, or without having achieved any documented result in terms of acquired skills, the Tuscany Region will not reimburse the costs of the scholarships for withdrawing PhD students, and that the The University for Foreigners of Siena is therefore required to request the return of the monthly payments received

- h) to be aware that cases of suspension from the doctorate are only those required by law, suspensions of different types are not normally acceptable
- i) to be aware that in the event of renunciation or interruption of the scholarship, the motivation must be communicated in writing to: Doctoral School - University for Foreigners of Siena – P.zza Carlo Rosselli 27/28 – 53100 Siena. The communication must arrive in good time so that it is possible for the University for Foreigners of Siena to send it to the Region within 5 days from the date of suspension of the scholarship;
- j) to be aware that specific topics for discussion are envisaged for the assignment of "Restricted Pegaso" scholarships for the purpose of verifying skills;
- k) to undertake to sign the unilateral deed of commitment which clearly sets out the requirements, conditions, constraints and fulfilments necessary for the acquisition and maintenance of the Pegaso scholarship, also with reference to the stay abroad;

**LASTLY, DECLARE :**

that I am aware that, pursuant to and by effect of EU Regulation 679/2016, personal data collected in connection to this procedure will be processed exclusively to fulfil obligations concerning publicity, transparency and dissemination of information by public administrations, in full compliance with the laws in force.
