d) to commit to attending the PhD course full-time according to the methods that will be established by the Teaching Body at the administrative and operational headquarters of the University, without prejudice to periods of study and research at companies and research centers and abroad, if applicable, scheduled consistently with the training and research activities planned at the University premises;

e) to undertake to write the doctoral thesis as indicated in the Regulations of the Doctoral Research Courses of the University for Foreigners of Siena;

f) to be aware of having to carry out mandatory periods of study and research in the company from a minimum of six (6) months to a maximum of eighteen (18) months, even if not continuous, over the three-year period;

g) further compulsory periods of study and research abroad, even non-continuous and even at multiple institutions, from a minimum of six (6) months up to a maximum of twelve (12) months over the three-year period, extendable to eighteen (18) for joint supervision;

h) to be aware that the periods of study and research referred to in letters f) and g) are distinct and must be carried out by separate entities;

i) to be aware that the bound research topic must be consistent with the specific planning within the Ministerial Decree. 630/24;

j) to commit to the drafting, through the appropriate online platform (http://dottorati.mur.gov.it), of a half-yearly report indicating the time commitment (broken down into months in the company, at the headquarters, abroad) and a summary of the main activities carried out, validated by the coordinator of the doctoral course in case of co-supervision of the thesis;


k) to be aware that failure to complete the stay abroad will result in the revocation of the entire scholarship;

I) to be aware that the modification of the project objectives and expected results (if not previously authorized by the MUR) will result in the revocation of the scholarship and the total refund of any amounts already paid;

m) to be available to attend courses for the acquisition of soft skills and knowledge about the world of work and research, which will be proposed by the implementing body during the three-year doctorate period.

n) to undertake to prepare annual reports for each year of the doctorate and a final report on the training activities attended and the research activities undertaken and the degree of satisfaction;

o) formally commit to respecting the deadlines established by the MUR, provide all the documentation and information requested by the University or by the MUR, and guarantee timely direct information to the University of any substantial variation that involves changes to the original objectives and expected results of the projects selected, or on the start and progress of any judicial, civil, criminal or administrative proceedings that may affect the operations covered by the project, also communicate any irregularities, fraud, cases of corruption and conflicts of interest found.
